SECTION 215.26.

A RESOLUTION DECLARING A SECTION LINE RIGHT-OF-WAY LOCATED ALONG MERIDIAN AVENUE BETWEEN NW 164TH STREET AND 150TH STREET ABANDONED

Whereas, a section line right-of-way along Meridian Avenue between NW 164th Street and 150th Street, Oklahoma County, Oklahoma has not been utilized or maintained by Oklahoma County and can be considered abandoned by Oklahoma County, Oklahoma; and

WHEREAS, the legal description of said section line right-of-way which has been abandoned is described as follows, and is hereinafter referred to as "Section Line Right-of-Way", to wit:

The East 33.00 feet of Section Three (3), Township Thirteen (13) North, Range Four (4) West of the Indian Meridian and the West 33.00 feet of Section Two (2), Township Thirteen (13) North, Range Four (4) West of the Indian Meridian less the North and South 50.00 feet thereof, all in the City of Oklahoma City, Oklahoma County, Oklahoma.


WHEREAS, the terrain underlying this section line right-of-way is unsuitable for road purposes for the reason that it is located within the floodway and thus, the Board of County Commissioners of Oklahoma County has not utilized or maintained said section line road and


WHEREAS, a substitute road exists within close proximity, to wit: Lone Oak Drive.

WHEREAS, there may be existing easements and right-of-ways held by other entities and the Board of County Commissioners does not intend to terminate or affect these easements and/or right-of-ways.

NOW THEREFORE BE IT RESOLVED, that the Board of County Commissioners of Oklahoma County does hereby declare that the above described Roadway Right-of-Way has been abandoned by the County; however, this Resolution has no force or affect on easements and/or right-of-ways held by other entities.
