

Agreement for Relief Pharmacy Services
Term of Contract: July 1, 2009 through June 30, 2010

This modification increases the "not to exceed" amount of the contract from \$15,000 to \$22,000 for f.y. 2009-10.

- 6) RPHS shall provide the above listed services to COUNTY on an "on-call/as-needed" basis; Payment for provision of pharmacist services shall not exceed Fifty-Eight Dollars (\$58.00) per hour, and payment for pharmacy technician or pharmacy clerk services shall not exceed Twenty Dollars (\$20.00) per hour. Total amount to be paid under this agreement is not to exceed Twenty-Two Thousand Dollars (\$22,000.00) over the term of the contract. If no pharmacists, pharmacy technicians, or pharmacy clerks are available in Oklahoma County, COUNTY will pay mileage in the amount of the IRS mileage reimbursement rate for a pharmacist, pharmacy technician, or pharmacy clerk to travel from place of residence to the County Pharmacy.






