A RESOLUTION REVISING THE BUILDING PERMIT AND BUILDING CODE INSPECTION FEES TO INCLUDE ADDITIONAL FEES FOR THE UBCC FOR THE UNINCORPORATED AREAS OF OKLAHOMA COUNTY, PURSUANT TO OKLAHOMA STATE STATUTES TITLE 59 §1000.25; 19 §868.4; Title 19 §868.17A.

WHEREAS, Section 1000.25 of Title 59 of the Oklahoma State Statutes directs the Oklahoma Uniform Building Code Commission (UBCC) to charge a fee for the issuance or renewal of any construction permit issued by any agency, municipality or other political subdivision of the state; and

WHEREAS, the fee shall be collected by the jurisdictional entity, on behalf of the UBCC, and be paid into the UBCC Revolving Fund by the 20th of each month for the preceding calendar month starting April 1, 2010; and

WHEREAS, each jurisdictional entity is allowed to collect up to an additional \$.50 (fifty cents) as an administrative fee on each permit reported; and

WHEREAS, Section 868.4 of Title 19 of the Oklahoma State Statutes authorizes the Oklahoma County Planning Commission to set building permit fees in the unincorporated areas of Oklahoma County; and

WHEREAS, on November 12, 2009 the Oklahoma County Planning Commission did approve the revision to the building permit fee to collect the additional fees imposed and established by the UBCC; and

WHEREAS, Section 868.17A of Title 19 of the Oklahoma State Statutes permits the Board of County Commissioners of Oklahoma County to determine fees for the purpose of carrying out building code inspections in the unincorporated areas of Oklahoma County; and

WHEREAS, under the authority of Oklahoma State Statutes Title 59 §1000.25; Title 19 §868.17A; and Title 19 §868.4; the following additional fees are hereby adopted by this resolution:

\$4.00 – UBCC required fee for each construction permit issued by the Oklahoma County Planning Commission, to be remitted to the UBCC Revolving Fund

\$.50 – Oklahoma County administrative fee for each construction permit issued by the Oklahoma County Planning Commission, to be retained by the Oklahoma County Planning Commission.
