FIRST RENEWAL OF MUTUAL COOPERATION AGREEMENT

CRUTCHO PUBLIC SCHOOLS & BOARD OF COUNTY COMMISSIONERS OF OKLAHOMA COUNTY

This FIRST RENEWAL OF MUTUAL COOPERATION AGREEMENT (the "RENEWAL") is effective the 1st day of July, 2010, between Crutcho Public Schools (the "School") and the Board of County Commissioners of Oklahoma County, a political subdivision and existing under the laws of the State of Oklahoma (the "County").

RECITALS:

WHEREAS, the School and County have entered into that certain Mutual Cooperation Agreement (the "ORIGINAL AGREEMENT") for proposed improvements at the School; and

WHEREAS, said ORIGINAL AGREEMENT expired on Oklahoma County's fiscal year-end of June 30, 2009, and the parties wish, by means of this FIRST RENEWAL, to extend the term of the ORIGINAL AGREEMENT, without any other changes to the said ORIGINAL AGREEMENT;

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties agree that the ORIGINAL AGREEMENT is hereby renewed through June 30, 2011. All provisions of said ORIGINAL AGREEMENT remain the same and in full force and effect and unabated.


