**OKLAHOMA COUNTY
ORDER OF INSPECTIONS**

1. Posting the building permit number and site address is an ICC requirement. The sign must be located within sight of the street and visible to the public.
2. ICC requires the builder or contractor to call and request an inspection for the stages of construction listed below:

Setbacks

Electrical Bonding

Electrical Service

Swimming Pool / Hot Tub Final

A fence must be installed, according to the ICC requirements, at the final inspection.

3. **Cost - \$44.50 per inspection.**
4. All Electrical, Mechanical, and Plumbing Contractors, Journeymen, and Apprentices must be licensed by the State of Oklahoma. All Electrical, Mechanical, and Plumbing Contractors must be registered with Oklahoma County before commencing any work
5. All inspections must be called in the day prior to the requested inspection by 4:30 p.m. The following are the contacts for inspection requests:
