Fireworks Stand Permit Requirements

ALL FEES ARE NONREFUNDABLE UPON RECEIPT BY THIS OFFICE.

Firework sales are permitted during the following times of the year:

- June 15 through July 6
- December 15 through January 2

A permit is required for each season - June through July and December through January.

- **Fireworks Stands in the unincorporated areas of Oklahoma County may only be erected in areas zoned R-2 - Rural Residential District and C-H - Highway Commercial District.**
- Fireworks sales and the structures from which fireworks are to be sold shall comply with all applicable requirements of the State Fire Marshal's Office, Oklahoma Tax Commission, and other State and Federal agencies having jurisdiction over fireworks sales.
- Sites for fireworks sales shall front or have direct access to section line roads or State highways.
- **The following codes shall be followed:**
 - **NFA 1124**
 - **IFC 2018**
 - **Oklahoma Statute Title 68, Article 16 Section 1621-1634**

The following documents are required:

- **Notarized landowner's affidavit or lease agreement must be provided with the application.**
- **Warranty Deed with Book and Page number must be provided with the application.**
- **Two (2) copies of a site plan, must be on at least 8.5" X 11" paper, of entire property including the following information:**
 - Setbacks from the centerline of the road, side and rear yard setbacks.
 - Property lines.
 - Proposed fireworks stand.
 - Parking Area.
 - Driveway location.
 - North arrow.

FEES

- \$100 per 20 linear feet of stand or portion thereof.
- \$300 per each tent.
- **\$200 Inspection Fee - This inspection will be completed by a third party inspector that Oklahoma County has selected to verify your stand is in compliance with the above listed requirements.**

Permit Requirements

ALL REQUIRED DOCUMENTS MUST BE RECEIVED, THE APPLICATION PROPERLY COMPLETED AND COUNTY ZONING AND BUILDING REGULATIONS ADHERED TO BEFORE A PERMIT WILL BE ISSUED.

ALLOW 3 - 5 WORKING DAYS FOR PERMIT PROCESSING.

- **The minimum setback from the side and rear yards is 25 feet.**
- **The minimum setback from a section line road is 100 feet from the center line of the road.**

Common Fireworks Stand Violations

- **Fireworks stands cannot be larger than 800 square feet. If the stand is larger than 800 square feet it will require a fire hydrant, fire sprinkler and fire alarm.**
- **Fireworks shall not be located in residential areas.**
- **Fireworks shall not be kept or stored within 100 feet of a residential dwelling.**
